TRI-BUILT® T-SA BASE is a fiberglass reinforced, self-adhering SBS modified base sheet with a polymer film on the surface with a split removable release film on the adhesive side. Alternatively TRI-BUILT® T-SA BASE can be mechanically fastened.

LIMITATIONS:

- Roof must have a positive slope with no ponding water.
- Caution: Apply materials only in fair dry weather when the interface temperature (air, roof deck, membrane) above 45°F and rising.
- Proper ventilation is required.
- For best application, prime exterior wood decking with TRI-BUILT® Quick Dry Asphalt Primer or ASTM D41 primer. All metal must be lightly primed with Tri-Built Quick Dry Asphalt Primer or ASTM D41 primer.
- Both the TRI-BUILT® T-SA Base Sheet and the TRI-BUILT T-SA Cap Sheet must be installed in the same day.
